

INFORMATIVA SULL'ACQUISTO DI AZIONI PROPRIE

El Towers S.p.A. comunica di aver acquistato sul Mercato Telematico Azionario, nel periodo compreso tra l'8 settembre 2016 e il 14 settembre 2016, n. 17.264 azioni proprie, pari a circa lo 0,06% del capitale sociale. Tali azioni sono state acquistate ad un prezzo medio pari ad Euro 48,0543 per azione, al netto delle commissioni, e quindi per un controvalore complessivo di Euro 829.609,52.

Gli acquisti sono stati effettuati nell'ambito del programma di acquisto di azioni proprie, il cui avvio è stato comunicato al pubblico in data 26 luglio 2016 e in esecuzione di quanto deliberato dall'Assemblea degli Azionisti del 21 aprile 2016.

REPORT ON THE PURCHASE OF TREASURY SHARES UNDER BUYBACK PROGRAM

During the period from September 8, 2016 to September 15, 2016, El Towers S.p.A. acquired No. 17,264 shares on the Milan Stock Exchange's Mercato Telematico Azionario (MTA) equal to 0.06% of the issued share capital. The shares were bought at an average price per share equal to Euro 48.0543, net of commissions, and for an aggregate amount of Euro 829,609.52.

These purchases were made pursuant to the plan to purchase treasury shares, announced on July 26, 2016, and in accordance with the resolution approved at the Company's General Meeting of Shareholders on April 21, 2016.

All the share purchase transactions on the MTA made from September 8, 2016 to September 14, 2016 are detailed in the annex.
